**REVISED ORDER ON RECEIVER'S EMERGENCY MOTION

THIS CAUSE HAVING come before the Court on July 9, 2008, by way of the *Receiver's Emergency Motion to Approve the Sale of Certain Receivership Assets Held By Relief Defendant Normandy Holdings II, LLC*, and the Court having heard argument of counsel, having heard the position of the Receiver, having reviewed the papers, and having been otherwise duly advised in the premises, it is hereby,

ORDERED AND ADJUDGED that:

1. The Receiver's Motion is GRANTED.
2. The Receiver is authorized to sell the assets of Normandy Holdings II, LLC, as set forth in the *Receiver's Emergency Motion to Approve the Sale of Certain Receivership Assets Held By Relief Defendant Normandy Holdings II, LLC*, consisting of Unit 187-1.
3. Pending further order of this Court, all proceeds from the sale, without deductions or set-offs, shall be held in escrow by the Receiver.
4. Additionally, the Receiver shall provide Normandy Holdings II, LLC, with an informal accounting relative to any claims and or damages relating to Normandy Holdings II, LLC, or any of its managing members or members, by August 11, 2008.
