THIS CAUSE HAVING come on before the Court on March 11, 2008 upon the *above-styled Motions*, and the Court having heard argument of counsel, having considered the position and recommendations of the Receiver, and being otherwise duly advised in the premises, it is hereby;

## **ORDERED AND ADJUDGED** that:

- 1. The Court finds it has jurisdiction over the assets that are the subject of the Motion.
- 2. The Receiver's Motion to reject the divorce settlement is Denied with respect to the funds currently held in the Receiver's Trust Account for the benefit of Kevin Berman. The Receiver is directed to pay these funds directly to the school which Kevin Berman attends.
- 3. Ruling is deferred with respect to the rejecting of the divorce settlement as to the Hanes City, Polk County, Florida property. The Receiver is authorized to sell the property and to escrow the funds in an interest bearing account. The Receiver is directed to complete an investigation into the acquisition of this property to schedule an evidentiary hearing for the Court to determine the appropriate distribution of the proceeds of the sale of this asset.
- 4. The Receiver is directed to investigate and obtain an accounting for the \$200,000.00 paid to Deborah Berman and the \$200,000.00 paid to Dana J. Berman from tax refunds received and distributed through the divorce proceeding and to thereafter make recommendations to the Court, on whether it is appropriate to bring actions under Florida Statutes §726.
