SECOND

AGREED ORDER FOR TRANSCAPITAL BANK'S RELIEF FROM TEMPORARY INJUCTION RELATING SOLELY TO THE PROPERTY LOCATED IN INDIAN RIVER COUNTY, FLORIDA

THIS CAUSE having come on to be heard on the agreement of counsel for the Receiver, Michael I. Goldberg and TRANSCAPITAL BANK, a Florida banking corporation, for Relief from the Temporary Injunction as same relates solely to the property located in Indian River County, Florida, currently owned by relief defendant DBDS Vero Beach, LLC, this Court finds:

- A. The State of Florida, Office of Financial Regulation, filed a Complaint for Temporary and Permanent Injunction and Appointment of Receiver on December 11, 2007, and,
- B. A Temporary Injunction and Agreed Order Appointing Receiver was entered by this Court on December 11, 2007 granting the Temporary Injunction and Appointing Michael I. Goldberg, as receiver.
- C. Transcapital Bank filed on October 30, 2007, a Complaint to Foreclose Mortgage and Other Relief in the Circuit Court of the Nineteenth Judicial Circuit in and for Indian River County, Florida, Case No. 20071496 to foreclose against the property ("Property") legally described on Exhibit "A" attached hereto.
- D. That the parties hereto by and through their respective counsel have agreed that TRANSCAPITAL BANK should be granted relief from the Temporary Injunction and these receivership proceeding so that it can continue to prosecute its foreclosure action, as it deems appropriate without restriction of any type.

IT IS HEREBY ORDERED AND ADJUDGED:

1. TransCapital Bank is hereby granted relief from the Temporary Injunction and the

pending receivership proceedings in this action. This Court shall no longer have jurisdiction over the property described in the attached Exhibit "A", other than to enforce the terms of this Order.

- 2. TransCapital Bank shall have full authority, without restriction, to pursue (or dismiss) its mortgage foreclosure action, (as it deems appropriate in its sole discretion), pending as Case No. 20071496 CA 09 filed in the Circuit Court of Indian River County, Florida, relating solely to the Property described on Exhibit "A".
- 3. M.A.M.C.. Incorporated is also released from the effects of the Temporary Injunction as the same relates to the Property described on Exhibit "A".
- 4. This Order supercedes this Court's previously entered Agreed Order dated February 7, 2008.
- 5. This Order shall take effect upon the payment to the Receiver, by TransCapital of the sum of \$15,000.00.
