**ORDER GRANTING RECEIVER'S SECOND MOTION FOR AN
ORDER APPROVING THE REVISED LANDOLOGY CONTRACT
FOR SALE OF THE ASSETS OF MAMC ISLAMORADA, LLC
AND APPROVING DISBURSEMENT OF PROCEEDS OF SALE**

THIS MATTER CAME ON before the Court on the Receiver's Second Motion for an Order Approving the Revised Landology Contract for Sale of the Assets of MAMC Islamorada, LLC and Approving Disbursement of Proceeds of Sale (the "Motion") at 8:30 a.m. on January 13, 2010, and the Court having reviewed the Motion, reviewed the procedures for service of the Motion, found that the method of service of the Motion was sufficient, and having heard the arguments of counsel it is:

ORDERED AND ADJUDGED as follows:

1. The Motion and all the relief requested in the Motion is GRANTED.

2. The Receiver, per the request of the title company, served the Lenders by certified first class, pre-paid U.S. Mail on December 11, 2009; and

3. The Court authorizes the Receiver to make the distributions outlined on page 4 of the Motion in paragraph 8 pursuant to the procedures set forth in paragraph 9 of the Motion.

4. The Receiver shall post a notice of final distribution of the sales proceeds (the "Notice") on the Receivership website. Unless objection to the proposed distribution is made by filing a written objection with this Court with service on the Receiver's attorneys within ten (10) days following the posting to the webpage, the Receiver is authorized to distribute the sales proceeds in accordance with the Notice.

5. If an objection is filed, the Receiver shall distribute any portions of the distribution to which no objection was filed in accordance with the Notice. Any portions of the proposed distribution subject to objection shall be held and the objection shall be set for hearing.
