**ORDER AUTHORIZING RECEIVER TO COMPENSATE INDIVIDUALS  
FOR SUBSTANTIVE CONTRIBUTION TO INSURANCE RECOVERY**

THIS MATTER came before the Court on February 27, 2017, at the hearing on the *Motion For Authority To Compensate Individuals For Substantive Contribution To Insurance Recovery* (the "Motion"), filed by Michael I. Goldberg, the receiver (the "Receiver") for Defendants Berman Mortgage Corporation, M.A.M.C. Incorporated, and Relief Defendants DB Atlanta, LLC, *et al.* The Court, having reviewed the Motion, heard argument of counsel, finding that the notice and established procedures of posting to the Receivership website and e-mail

distribution to the lenders, constitutes adequate notice of this Motion, the hearing thereon and this Order, and being otherwise fully advised in the premises, does:

**ORDER AND ADJUDGE** that:

1. The Motion is GRANTED.
2. The Receiver is authorized to compensate Jerilynn Gidney, Gail Corenblum, and the estate<sup>1</sup> of Marvin Katz, for their substantive and invaluable assistance towards the recovery of the Insurance Settlement (as more fully described in the Motion).
3. The Receiver shall pay the sum of \$10,000 to Jerilynn Gidney; the sum of \$5,000 to Gail Corenblum, and the sum of \$5,000 to the estate of Marvin Katz, from the net proceeds recovered in the Insurance Settlement.
