**ORDER GRANTING RECEIVER'S MOTION TO EXPAND RECEIVERSHIP  
TO INCLUDE MAMC BILOXI, LLC AS A RELIEF DEFENDANT, *NUNC PRO TUNC*,  
AND FOR AUTHORIZATION TO ENTER INTO AN EXCLUSIVE  
LISTING AGREEMENT WITH COLDWELL BANKER ALFONSO REALTY TO  
MARKET AND SELL A PORTION OF MAMC BILOXI, LLC'S PROPERTY**


THIS MATTER came before the Court on September 19, 2012 at the hearing on the *Motion to Expand Receivership to Include MAMC Biloxi, LLC as a Relief Defendant, Nunc Pro Tunc, and for Authorization to Enter into an Exclusive Listing Agreement with Coldwell Banker Alfonso Realty to Market and Sell a Portion of MAMC Biloxi, LLC's Property* (the "Motion"), filed by Michael I. Goldberg, the receiver (the "Receiver") over Defendants Berman Mortgage Corporation, M.A.M.C. Incorporated, and Relief Defendants DB Atlanta, LLC, *et al.* The Court,

having reviewed the Motion, heard argument of counsel, finding that the notice and established procedures of posting to the Receivership website and e-mail distribution to the Lenders constitutes adequate notice of this Motion, the hearing thereon and this Order, and being otherwise fully advised in the premises, does:

**ORDER AND ADJUDGE that:**

1. The Motion is GRANTED.
2. The Receiver is authorized to expand the Receivership to include MAMC Biloxi, LLC as a Relief Defendant, *Nunc Pro Tunc* to January 18, 2012, as further described in the Motion.
3. The Receiver is also authorized to enter into the exclusive listing agreement with Coldwell Banker Alfonso Realty as further described in the Motion.
